## PRIVATE NOTICE

On 21<sup>st</sup> August 2015 I was travelling in my private conveyance, lawfully recorded with the Republic of Good Hope >>> http://www.republicofgoodhope.com <<< record number RG74792H, from Barrydale to Swellendam; passing through Suurbraak, the customary pathway was blocked by agents for the RTMC (Road Traffic Management Corporation), one of them standing in the middle of the way. Upon stopping, I asked in which way I could possibly assist them, an unidentified female agent asked me a for a license; I informed her that I do not carry or have a license, but am in possession of a travel card, which is the equivalent (under common law) to a license (in statutory law); the agent said, that by law everyone must have a license, in response to which I informed her about the Republic of Good Hope, a common law society as well as the corporatization, capitalization and privatization of all once public offices. I asked whether she knew the difference between a corporate government and a people's government or that since 2005 South Africa no longer had a traffic department, a public utility or office, but something called the RTMC, privately owned, with a board of shareholders and a CEO; unlike other agents and/or peace officers (if under oath) who I have encountered, she remained very stubborn, insisting to issue a fine; I let her do her job, as to not aggravate of embarrass her any further; at no time did I identify myself as a CITIZEN, an employee of RSA (Pty) ltd or person subject to any acts of this fraudulently imposed foreign jurisdiction, known as cannon, maritime, admiralty or civil law. South Africa is one of ca. 20 counties with a dual system of civil and common law, the latter to be recognized as per act 108 of 1996, the so-called constitution of RSA (Pty) ltd; the incident was recorded and is available on youtube :

to summarize, no crime was committed, the alleged fine and invitation to court was never accepted and/or autographed, thus renders it null & void, i.e. not forming a lawful contract; nevertheless, I used the opportunity and visited the court in Swellendam on the suggested day, 10<sup>th</sup> November 2015, to explain the circumstances and educate the people unknowingly working for the corporation; in court, after decreeing a court of record, magistrate Groenewald suggested to contact the public prosecutor before the next court date on 1<sup>st</sup> December 2015.
