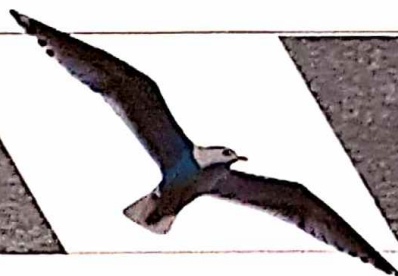

RGH incidents and RSA courts

Incident August 2015 : alleged charge traffic code violation

Swellendam Magistrates Court **THE STATE vs. Jan Lohfeldt** Case No. V/6222/15

multiple court visitations, Magistrate Groenewald assured trial date,

but was not present on trial, thus magistrate Delpont struck the matter off the roll, not wanting to entertain the matter any longer

Incident June 2016 : detention, alleged charges traffic code violation and false identification

Cape Town Magistrates Court **THE STATE vs. Vincent Paul Theunissen** Case No. 24/1006/16

visit to public prosecutor's office on day of hearing, coercing an admission of guilt, including criminal record and payment of 50% of initial fine, under threat of unfavourable outcome, i.e. R60.000 and 6 months prison. 4-6 weeks later, after an alleged case review, fine was set aside, criminal record cleared and money to be paid back to Paul. Apparently because the warrant was not served according to the statutory requirements.

Incident July 2017 : alleged charges traffic code violation, confiscation of RGH property, threat of arrest by officer Zukelwa via telephone

Knysna Magistrates Court **THE STATE vs. Jan Lohfeldt** Case No. V/1635/17 & 1634/17

2 court visitations, ready for trial, but magistrate Thafeni elected to strike the matter off the roll,

instructing officer Payle to restore RGH property, which has not happened until today.

Incident March 2018 : detention, alleged charges fraud, confiscation of RGH property

George Magistrates Court **THE STATE vs. Hylton Knowles** Case No. C389/18

multiple court visitations, on trial magistrate Grobber elected to dismiss fraud charges and proceed with traffic code violations instead, thus transferring the matter to the George municipal court. On 19th November 2018 at municipal court magistrate Joubert granted a not guilty verdict, based on section S174 of the criminal procedure act, i.e. THE STATE could not provide enough evidence and RGH was not in contravention of the NRTA

Incident October 2018 : detention, alleged charges fraud, confiscation of RGH property,

Knysna Magistrate Court **THE STATE vs. Jan Lohfeldt** Case No. 306/10/18

1 court visitation, prosecutor Gqalangle matter did not enroll, based on outcome in Hylton's Case, endorsed by control prosecutor Engelbrecht.

Incident May 2019 : alleged charges traffic code violation, confiscation of RGH property, threat of arrest by officer Oliphant via telephone

Knysna Magistrates Court **THE STATE vs. Karin Robichon**

multiple court visitations, magistrate Swartz confirmed trial date, on trial date, during an off record meeting with RGH members and RTMC agents, it became evident to prosecutor Premchand, who had no knowledge of but a general interest in RGH, that the RTMC had not done any investigation into RGH and the alleged statutory violations. Although Karin and Premchand were in full support of a trial at a future date, magistrate Hendricks decided to strike the matter off the roll, according to him THE STATE had enough time to make its case, but failed to do so.
